Scope of this Privacy Policy

- **3.** This Privacy Policy applies only to the actions of Momentum Asset Management Limited T/A National Homebuyers and Users with respect to this Website. It does not extend to any Websites that can be accessed from this Website including, but not limited to, any links we may provide to Social Media Websites.

Data Collected

Data that is given to us by you

- **7.** Momentum Asset Management Limited T/A National Homebuyers will collect your Data in a number of ways, for example:

Data that is collected Automatically

- **8.** To the extent that you access the Website, we will collect your Data automatically, for example:

Our Use of Data

Keeping Data Secure

Data Retention

- **16.** Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your Rights

- **17.** You have the following rights in relation to your Data:
